Consumption Dosage

ARSTEP EXTRA 180 is used 0,8 – 1,5 % of total binder weight.

Method of Application

Aggregates and the binder (cement-silica fume-fly ash-blast furnace slag) should be mixed until obtaining a homogenous mixture. After adding 70% of mixing water into the dry mixture, **ARSTEP EXTRA 180** should be added into the rest of water and should be mixed properly.

Compatibility with other admixtures

ARSTEP EXTRA 180 can be combined with the following admixtures. Laboratory tests should be carried out before use.

Packaging

- 30 kg plastic drum
- 250 kg barrel
- 1000 kg container

Storage and Shelf Life

Must be stored at temperatures between +5 $^{\circ}$ C and +35 $^{\circ}$ C. Under proper storing conditions, the products shelf life is 12 months from production date if kept in original packaging unopened and undamaged. Packaged products must be shaken before use.

Concrete mix design and admixture dosage should be determined by laboratory tests according to the concrete class and properties.
